We will develop processes and products that help Kensing, our value chain partners, and our customers to minimize our collective environmental footprint and impact on climate change, for example by promoting solutions that have an equivalent or lower carbon footprint than their alternatives. We will develop and promote technologies and products

that enable us to manage and reduce our impacts from waste and air and water emissions.
